

Wild Roots Summer Program Agreements

- I agree that I will not attend Wild Roots within 14 days after returning from areas highly impacted by COVID-19 subject to a CDC Level 3 Travel Health Notice.
- I agree that I will not attend Wild Roots within 14 days of exposure to any person returning from areas subject to a CDC Level 3 Travel Health Notice.
- I agree that it is my responsibility to be aware of said highly impacted areas. (<https://www.cdc.gov/coronavirus/2019-ncov/travelers/index.html>)
- I agree that I will not attend Wild Roots within 14 days of exposure to any person who has a suspected or confirmed case of COVID-19
- I agree that my child(ren) will not visit or attend Wild Roots if he/she/they experience symptoms of COVID-19, including fever, cough, shortness of breath, or a suspected or diagnosed case of COVID-19.
- I agree to practice physical distancing at drop off and pick up each day.
- I agree to wear a mask at pick up and drop off.
- I agree to limit those who can drop off or pick up my child, to household members, and/or other parents within the program group.
- I agree to do everything in my power to drop off and pick up my child during my prescribed pick up and drop off time slot, so as to avoid large gatherings of adults.
- I understand that my child(ren) will not be asked to practice physical distancing from other children nor from their teachers.
- I understand that under most circumstances, my child will not be made to wear a mask while attending Wild Roots.
- I understand that Wild Roots teachers will not, under most circumstances, wear a mask throughout the program day.
- I agree to send all of my child's belongings clearly labeled with their name.

- I understand that toys and tools from home are not permitted at Wild Roots. (i.e. binoculars, field guides, dolls or animal figures, etc.)
- I agree to bring a completed and accurate health attestation form for my child each morning. (Said forms will be provided for each family)
- I understand that Wild Roots staff will check my child's temperature each morning upon arrival, with a no-touch thermometer.
- I agree that should my child(ren) or household member begin to show signs and symptoms, especially fever, that individual will get tested for COVID-19 and the results will be shared with Wild Roots. All individual privacy will be carefully maintained.
- I agree to both keep my child(ren) home should they present signs and symptoms and notify Wild Roots.
- I understand that should my child have a fever of 100 degrees or higher, or other signs and symptoms, all parents within the cohort will be notified, while maintaining individual privacy.
- I understand that should a child within the cohort have a fever or other signs and symptoms and I am notified, it is incumbent on me to practice care within the larger community and avoid contact with folks outside of the cohort.
- I have read and understood the refund policy.
 - Cancelation & Refund Policy*
 - We understand that a great deal of uncertainty remains and that we are all taking some risk in engaging in summer programs.*
 - Cancelation up to 3 days after payment provides a refund of fees paid, less \$50.*
 - Cancelation up to 2 weeks prior to program start date provides a refund of fees paid, less \$100.*
 - No refunds are available after 2 weeks prior to each session's start date.*
- I agree that at least one parent/guardian will attend an online webinar on these new protocols, hosted by Wild Roots, before my child attends.
